

## VOTING AT THE SHAREHOLDERS' MEETING

The voting process will start as from the official convening of the Shareholder's Meeting, scheduled on October 31, 2011.

To be eligible to vote in accordance with French legislation, your InfoVista shares have to be registered at midnight, CET, on November 10, 2011, either as nominative shares (recorded in a BNP PARIBAS Securities Services account) or as bearer shares (recorded in an account held by your bank or broker).

If your InfoVista shares are registered as nominative shares, you will be sent a proxy form on October 31, 2011. **If your InfoVista shares are in bearer form, you will be able to obtain a proxy form from your bank or broker. You may receive your proxy from October 31, 2011 to November 10, 2011.**

The proxy form allows you to choose:

- 1) to attend the Shareholders' Meeting by requesting an attendance card,
- 2) to make a postal vote, or
- 3) to give proxy to the Chairman of the Shareholders' Meeting, your spouse (if applicable) or a designated InfoVista shareholder.

A proxy to the Chairman of the Shareholders' Meeting shall result in the issuance of your votes in favor of adopting draft resolutions submitted or approved by the Board of Directors and a vote against adopting any other draft resolutions. To issue any other vote, you must appoint a proxy who agrees to vote in the manner you indicate.

In each case, you must fill out the appropriate form with your name and address and then date and sign it.

If your InfoVista shares are registered as nominative shares, you must fax the completed form or mail it to the following address, where it must be received no later than 3pm CET November 15, 2011 (we recommend faxing the proxy form):

**Bearer shareholders must send the proxy form to their banker or broker, which will transfer the form to BNP PARIBAS Securities Services. Your broker or bank shall be responsible to fax or send the proxy form to BNP that must be received no later than 3pm CET November 15, 2011 (at the above address) along with a certificate of ownership indicating that the shares are recorded in your account as of November 10, 2011.**

If you do not receive your attendance card in time, you may still come to the Shareholders' Meeting. Assuming you have your certificate of ownership (if your shares are in bearer form), you will be issued an attendance card at the registration desk. This is not the usual procedure, however, and we request that you avoid it if at all possible.
